

**RESOLUTION NO. 594-2021, AUTHORIZING AND APPROVING
A SETTLEMENT AGREEMENT TO AN ACTION RELATING TO
THE OPIOID CRISIS (WALGREENS)**

WHEREAS, there is pending the matter of County of Suffolk v. Purdue Pharma L.P., et al., under Index No. 400001/2017 in the Supreme Court, Suffolk County, regarding the opioid addiction crisis, in which the County of Suffolk is the named plaintiff in the action (the "Action"); and

WHEREAS, the Action is against several defendants, including manufacturers of opioids, distributors of opioids and chain pharmacies; and

WHEREAS, the Action alleges four causes of action against defendants Walgreens Boots Alliance and Walgreen Co. ("Walgreens"), including but not limited to a claim for public nuisance due to Walgreen's failure to effectively monitor and report suspicious orders of prescription opioids from its retail stores and failure to implement measures to prevent diversion of prescription opioids in connection with its distribution of prescription opioids to its retail pharmacies, which contributed to an increase in opioid overdose and addiction which contributed to a public health crisis in Suffolk County; and

WHEREAS, defendant Walgreens has offered to settle the County of Suffolk's claims against it by paying the sum of Five Million (\$5,000,000.00) Dollars; and

WHEREAS, the Department of Law has approved a settlement agreement and release ("Agreement") and the Agreement is attached hereto as Exhibit "A"; and

WHEREAS, it is in the best interest of the County of Suffolk to resolve this matter with respect to Walgreens without further litigation and enter into the proposed Agreement as it shall settle all allegations against Walgreens and avoid protracted litigation; now, therefore be it

1st **RESOLVED**, that the execution and delivery on behalf of and in the name of the County of Suffolk by the County Executive, or his designee, of the proposed Agreement attached hereto as Exhibit "A" is hereby authorized, and the County Executive, or his designee, is hereby authorized, subject to County Attorney approval, and directed to execute the proposed Agreement in a form substantially similar thereto and execute such other documents as may be necessary and appropriate to effectuate the settlement with Walgreens; and be it further

2nd **RESOLVED**, that this Legislature, being the State Environmental Quality Review Act (SEQRA) Lead Agency, hereby finds and determines that the adoption of this resolution constitutes a Type II Action pursuant to Section 617.5(c)(26) and (33) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management, and information collections, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
