**RESOLUTION NO. 754-2021, AUTHORIZING AND  
APPROVING A SETTLEMENT AGREEMENT TO AN ACTION  
RELATING TO THE OPIOID CRISIS (ENDO)**

**WHEREAS**, there is pending the matter of County of Suffolk v. Purdue Pharma L.P., et al., under Index No. 400001/2017 in the Supreme Court, Suffolk County, regarding the opioid addiction crisis, in which the County of Suffolk is the named plaintiff in the action (the "Action"); and

**WHEREAS**, the Action is against several defendants, including manufacturers of opioids and distributors of opioids; and

**WHEREAS**, the Action alleges several causes of action against defendants Endo Health Solutions, Inc., Endo Pharmaceuticals, Inc., Par Pharmaceutical, Inc., and Par Pharmaceuticals Companies, Inc. ("Endo/Par"), including but not limited to a claim for falsely marketing prescription opioids and a claim for failure to effectively monitor and report suspicious orders of prescription opioids and/or failure to implement measures to prevent diversion of prescription opioids, which contributed to an increase in opioid overdose and addiction which contributed to a public health crisis in Suffolk County; and

**WHEREAS**, Endo/Par has offered to settle the County of Suffolk's claims against it by paying the sum of Thirteen Million, Eight Hundred and Fifty Thousand (\$13,850,000) Dollars; and

**WHEREAS**, it is in the best interest of the County of Suffolk to resolve this matter with respect to Endo/Par without further litigation and enter into a settlement agreement and release ("Agreement"), the form of which is annexed hereto as Exhibit "A", as it shall settle all allegations against Endo/Par and avoid protracted litigation; now, therefore be it

**1<sup>st</sup>** **RESOLVED**, that the execution and delivery on behalf of and in the name of the County of Suffolk by the County Executive, or his designee, of the proposed Agreement attached hereto as Exhibit "A" is hereby authorized, and the County Executive, or his designee, is hereby authorized, subject to County Attorney approval, and directed to execute the proposed Agreement in a form substantially similar thereto and execute such other documents as may be necessary and appropriate to effectuate the settlement with Endo/Par; and be it further

**2<sup>nd</sup>** **RESOLVED**, that this Legislature, being the State Environmental Quality Review Act ("SEQRA") Lead Agency, hereby finds and determines that the adoption of this resolution constitutes a Type II Action pursuant to Section 617.5(c)(26) and (33) of Title 6 of the NEW YORK CODE OF RULES AND REGULATIONS (6 NYCRR) and within the meaning of Section 8-0109(2) of the NEW YORK ENVIRONMENTAL CONSERVATION LAW as a promulgation of regulations, rules, policies, procedures, and legislative decisions in connection with continuing agency administration, management, and information collections, and the Suffolk County Council on Environmental Quality (CEQ) is hereby directed to circulate any appropriate SEQRA notices of determination of non-applicability or non-significance in accordance with this resolution.
